CONTENT OF SAMPLE CHECKLIST

Our *Checklists* act as a blueprint for reopening preschools/nurseries. It is a list that provides leaders with a tool to spearhead the process of change. We expect it to be updated, possibly on a daily basis, due to the nature of the pandemic. Therefore, it is a document that evolves. Here are then (10) sample items, we have at least seventy (70) on our current list:

Prepare an action plan as if it was the first day of opening.
Familiarise yourself with all relevant government guidelines.
Prepare a 'Frequently Asked Questions' document
Update your website and all social media accounts
Prepare and share a survey for parents, to gain their views
Contact each family directly
Set up a designated email address, for reopening enquiries
Create a designated phone number for reopening enquiries
Err on the side of over communicating with staff and families
Provide information for children with special needs
